Cuba: The NED invested 5 million dollars to turn over the island's government

According to the data of the US agency itself, in just one year, in the middle of the pandemic and while Washington deepened the measures of the illegal blockade against the island, through the National Foundation for Democracy the US government invested 5 million dollars to defame, attack and destabilize the Cuban government.





In 1983, Republican President Ronald Reagan gave birth to the National Endowment for Democracy (NED). Since its inception, this organization, together with the United States

Agency for International Development, known by its acronym in English as USAID (United States Agency for International Development), has functioned as one of the economic arms of the interventionist policy of the United States government, financing Non-Governmental Organizations (NGOs) and foundations, which disguise themselves with names of very laudable values (such as democracy or freedom), but they are intended to destabilize governments that do not align with Washington's policies.



These interventionist policies have been developed in many countries of the world, especially in those that are in what the United States considers its "backyard": Latin America and the Caribbean.

As detailed on the organization's own website, "In 2020, the LAC program of the National Endowment for Democracy (NED) provided fundamental support to promote democracy in countries under the most authoritarian regimes: Cuba, Nicaragua and Venezuela. Two countries in transition, Ecuador and Bolivia, offered important opportunities to reverse previous authoritarian legislation on freedom of expression and judicial independence, and to encourage citizen participation in electoral processes. In the Northern Triangle, the NED expanded anti-corruption, digital media and human rights programs. The NED reaffirmed commitments to the largest countries in the region: Brazil and Mexico, which currently face threats from right- and left-wing populist governments, respectively" (National Endowment For Democracy official website: <u>https://www.ned.org/region/latin-america-and-caribbean/).</u>

As can be seen, the organization calls those of Cuba, Nicaragua and Venezuela "more authoritarian regimes", countries that were openly attacked through the network of foundations and NGOs that this entity has and defamed from the media that are also

financed through these organizations or similar entities, media that have a clear alignment with the policies of the US State Department.

In the same paragraph they refer to Bolivia as a country "in transition", when, in reality, it had suffered a coup d'état (2019) and at that time (year 2020) was under the de facto government of Jeanine Áñez and Arturo Murillo. It is also said that Brazil and Mexico "currently face the threats of populist governments", putting the government of Jair Bolsonaro in the same line with that of Andrés Manuel López Obrador.

On the NED page, it is also reported that, on November 30, 2018, a meeting was held in which Democratic Senator Robert "Bob" Menéndez and the Republican member of the House of Representatives, Ileana Ros-Lehtinen, two recognized activists against the popular processes of the region and with links to the most reactionary sectors of Cuban emigration based in Miami, participated. Joining them were NED President Carl Gershman and USAID Administrator Emb. Mark Green(https://www.ned.org/events/working-towards-a-hemisphere-of-freedom-

<u>connecting-democratic-leaders-in-cuba-nicaragua-and-venezuela/)</u>:"CSIS introduced NED leaders at a November 30 event with a focus on Latin America titled Working Toward a Hemisphere of Freedom: Connecting Democratic Leaders in Cuba, Nicaragua, and Venezuela. Following opening remarks by U.S. Senator Robert Menendez (D-NJ), NED President Carl Gershman participated in a conversation with House International Relations Committee Chairwoman Ileana Ros-Lehtinen (R-FL) and USAID Administrator Emb. Mark Green. Gershman took the opportunity to thank Congresswoman Ros-Lehtinen for her unwavering support for the work of democratic activists around the world and handed her a framed impression of the Goddess of Democracy, originally built by student democracy activists in China's Tiananmen Square nearly 30 years ago. Later, NED's senior director for Latin America and the Caribbean, Miriam Kornblith, participated in a panel with activists from Venezuela and Cuba, moderated by CSIS's Moises Rendon."

"This event brought together U.S. development agencies and legislators with democratic leaders from Cuba, Nicaragua, and Venezuela."

Cuba in the crosshairs

Since the triumph of the Cuban Revolution in 1959, the United States has sought in every way to force a change of government on the island. The criminal economic, commercial and financial blockade that Washington illegally and unilaterally maintains against the island, and that has been rejected by the vast majority of the international community in 29 votes in the United Nations (UN) is, without a doubt, the most concrete example of that systematic aggression that the US government maintains against that people.

The promoters of the blockade have confessed on more than one occasion that this series of measures are intended to suffocate the Cuban people, cause chaos and thus generate a change of government and political system (which they usually synthesize in the expression "regime change").

During the pandemic years, 2020 and 2021, the US government (first with the leadership of Donald Trump and then with that of Joe Biden) deepened the blockade with new measures. The entry of medicines, respirators, fuel and economic resources to face the crisis caused by Covid-19 was prevented. In this context, protests were fomented to destabilize the government and thus try to give the island the final blow (a new failed attempt that generated discomfort and suffering in the Cuban people, but that failed to bend it).

In the chapter dedicated to Cuba on the NED's own page, the list of resources that, during the year 2020, that organization has destined to promote destabilization on the island (destabilization that the agency makes up with the supposed purpose of "promoting democracy") is shown.

According to the data released on the official website of the NED(<u>https://www.ned.org</u>), during that year almost 5 million dollars (\$5,077,788) were invested, to which must be added the resources contributed to NGOs and Foundations that do not appear in the Chapter on Cuba, but that act on the island and, also, add the funds channeled through USAID and other similar organizations.

Below, we reproduce the long list that the NED published on February 23, 2021, on its official website(<u>https://www.ned.org/region/latin-america-and-caribbean/cuba-</u>2020/) where the NGOs and foundations that received money to intervene in Cuba during 2020 are detailed (with figures ranging from 20 thousand to 650 thousand dollars):

Advocating for a human rights framework in EU-Cuba relations

International Platform for Human Rights in Cuba

\$ 87,253

Advocate for the inclusion of human rights and the perspectives of Cuban civil society as part of the EU's engagement with the Cuban government. The beneficiary will oversee the implementation of the EU-Cuba bilateral treaty and engage relevant actors in the EU to present them with the views and needs of Cuban civil society. The group will also promote a greater understanding by Cuban activists of the opportunities offered by the new EU-Cuba relations framework to promote human rights in Cuba.

Document and denounce human rights violations in Cuba

Cubalex

\$ 150 000

Document and denounce human rights violations in Cuba. The organization will work with civil society groups on the island to document human rights violations in accordance with international standards. With this information, it will provide legal assistance to victims on the island, report on Cuba's human rights record to international organizations and governments, and advocate for greater respect for human rights and protection for victims in Cuba.

Empowering Cuban hip hop artists as leaders in society

Urban Poster Foundation

\$ 110 000

Empower Cuban artists to promote citizen participation and social change. The group will hold workshops, cultural exchanges and artistic events during its Hip Hop Summit in Colombia. It will promote South-South collaboration and invite artists from around the world to share their experiences of social transformation. The organization will advise artists and provide technical capacity to strengthen their work. The group will also raise awareness of the role hip-hop artists have in strengthening democracy in the region.

Empowering Cuban women to reduce gender-based violence

National Democratic Institute for International Affairs (NDI)

\$ 500 000

To increase Cuban women's knowledge of gender rights and issues, enable men to become partners in these efforts, and strengthen the capacity of Cuban activists to promote and advocate for new laws and public policies that address and reduce violence against women, the Institute will facilitate an observatory to support the monitoring and collection of statistical data around gender-based violence and politics, as well as clinics and gender laboratories to support participants in identifying and pressing for solutions to the problem of gender-based violence in Cuba.

Promotion of a plural information space in Cuba

Freedom of information

\$ 80 000

Promote freedom of expression and a plural and independent information space in Cuba. The organization will cover stories of the Cuban reality on the island and of the Cuban diaspora. It will focus on making the information available to a wide audience in Cuba and will develop partnerships with media abroad to reach a wider audience.

Fostering Independent Thought and Writing in Cuba

Hypermedia Publishing House Inc.

\$ 93,941

Promote greater freedom of expression and independent writing among Cuban intellectuals. The organization will collect and distribute censored books produced by exiled Cuban writers to intellectuals on the island. The organization will conduct two essay contests to encourage independent writing among its target audience and will produce and distribute a biannual print magazine in Cuba. Finally, the organization will publish the winning pieces of its essay contests and present them at book fairs and other relevant spaces.

Fostering New Democratic Leadership in Cuba

Latin American Center for Nonviolence

\$48,597

Strengthen the leadership skills and organizational capacity of the Coalition of Self-Employed Workers of Cuba (C3). With the support of LACENV, C3 will produce and distribute an organizational newsletter, hold a fair for freelancers and organize a workshop for women entrepreneurs. LACENV will also help C3 organize virtual and face-to-face trainings for self-employed workers and include other sectors of the population in C3.

Freedom of expression in Cuba and inclusion in the regional agenda of Latin America Institute of Communication and Development

\$ 79,300

Promote awareness and discussion about violations of freedom of expression (FSO) in Cuba. The organization will collaborate with Cuban partners to incorporate Cuba into their regional reports on FSO and Access to Public Information. It will also work with Cuban civil society to prepare a comprehensive report to be shared with the United Nations Human Rights Committee in Geneva. The organization will also hold formal and informal advocacy meetings with its Cuban partners while in Geneva.

Raising awareness of Cuba's role in the region and assessing challenges to democratic consolidation

Electoral Transparency

Monitoring and sensitization on the state of human rights in Cuba

Cuban Observatory of Human Rights

Monitor and raise awareness internationally about the human rights situation in Cuba, including the effects of COVID-19. The beneficiary will submit urgent requests for the protection of victims to UN agencies and will produce monthly reports, statements and press releases to report on violations to national and international actors. The beneficiary will expand their international advocacy efforts with relevant international stakeholders.

Promoting access to independent sports coverage in Cuba

Freedom of information

\$ 50 000

Promote freedom of information in Cuba by providing public access to independent sports news and analysis. The organization will produce and disseminate journalism through its platforms that use sport as a vehicle to narrate the political, social and cultural realities of Cuban society. Fight impunity in the face of human rights violations and raise awareness about social conflicts in Cuba. The organization will work with partners on the island to document actions and publicly expose perpetrators of human rights violations. The beneficiary will also support citizens to peacefully document and resolve cases of social conflict in their communities.

Promotion of community reporting in Cuba

Cuban Institute for Freedom of Expression and Press

\$ 146,360

Promote greater access to uncensored information in Cuba's communities and strengthen the capacity of community journalists. Based in Miami, the dealership will support six independent community media outlets across the island to produce newsletters for local residents. The fellow will provide their counterparts in Cuba with the equipment and technical assistance necessary to design and print these newsletters.

Promotion of freedom of expression and independent media in Cuba

Freedom of information

\$ 56,500

Promote freedom of expression and a plural and independent information space in Cuba. Supporting independent journalism in Cuba

War and Peace Reporting Institute (IWPR)

Strengthen collaboration among independent Cuban journalists to promote freedom of expression. The grantee will work with various independent journalists and media organizations to promote mutual understanding and solidarity among them, and to strengthen their skills in the use of social media. The organization will also encourage and support collaborative efforts among journalists affiliated with different media outlets.

Support for independent trade unions, the self-employed and labour rights

International Group for Corporate Social Responsibility in Cuba

\$ 230 000

Promote labor rights and strengthen the capacity of Cuba's independent trade union movement. The organization will provide assistance to independent labor activists in Cuba to forge a more coordinated labor movement on the island. In addition, the organization will work with a nascent association of self-employed workers to promote labor rights in the informal sector. It will also carry out an international campaign to disseminate and raise awareness of information on the situation of labor rights in Cuba.

Support for independent writers and artists in Cuba

Vista Larga Foundation Corp

Support Cuba's independent writers and artists to freely produce and disseminate their work. The organization will help writers strengthen the quality of their work and publish pieces on and off the island. The organization will also raise awareness of repression targeting freelance writers, artists and musicians through online campaigns.
