The Latino mafia and the elections in the United States

The list of Miami-based mafia and terrorist organizations is too extensive to include in an article, but suffice it to say that, with exceptions, it is consistent with their degree of impunity, some for having belonged to the CIA and others for their political connections.

In December 1980, months after the assassination of Monsignor Oscar Romero and for the same reasons, four American nuns were ambushed on a highway in El Salvador. After raping them, they murdered them, buried them in a well and set fire to the van in which they were traveling.

By For years, the U.S. government tried to blame the incident on the left-wing guerrillas, in which peasants had taken refuge beset by the genocidal brutality of the military junta government of El Salvador. But the relatives of the nuns were not convinced by the arguments that came out of the White House and were reproduced in the great press. After the massacre of the Jesuits in 1989 at the hands of the group paramilitary Atlacatl, another creation of the School of the Americas and responsible for multiple massacres, such as El Mozote in 1981, Cracks began to appear in the narrative and the soldiers who They participated in the murder of the four nuns and began to speak.

The American nuns and Spanish Jesuits were human beings with Name and surname, that is, people with rights. The 75,000 Salvadorans massacred in just 12 years, the overwhelming majority at the hands of the military and paramilitary of the Washington-backed regime, never were enough to force some political change or negotiations of peace that followed in the 90s.

Thousands of survivors of another unimportant genocide managed to escape from the killings, economic chaos and social terror that followed what was conveniently called the "Civil War." Wives, children and Brothers of the massacred (in some cases, the army took the children by the feet and burst them on the stones to save bullets), some of whom I know, such as the poet Carlos Ernesto García, They had to emigrate. Most came to the United States, for a simple reason for job possibilities.

How in the rest of the dictatorships since the nineteenth century, that of the Junta Revolutionary, that of Napoleon Duarte and the Salvadoran oligarchy it was protected and financed by Washington and private sectors. The The same story happened in the Panama of the CIA's favorite narco, Manuel Noriega, in Honduras of Battalion 3-16 (another paramilitary group trained by the CIA) and in the Guatemala of the genocidal Ríos Montt, who Not only did it receive moral, military and economic support from the government of Ronald Reagan but also of Protestant churches such as the powerful televangelist Pat Robertson, the same one who supported dictatorships in Africa and which proposed in 2005 the assassination of Hugo Chávez as "the way to more economical" to solve "the problem" of another president democratically elected but disobedient.

Once *thenobodies* fled of the chaos of Central America and crossed the southern border of the United States United, they were received with bullets by different paramilitary groups, such as the CMA (*Civilian Materiel Assistance*), created by the CIA in 1984 to perform in Central America and with ties to the Alabama KKK), and Other mercenaries who in the 80s had trained the terrorist group of the Contras in Nicaragua. Once back in their country,

they repeated the Well-known speech of "*this is a country of laws and we have the right to protect our borders from invaders.*"

At the same time that the victims of the barbarism imposed and financed in the former banana republics were criminalized, the generals responsible for the massacres in those same countries, as tradition indicates, flew to Florida, where they began a new life, not by chance, full of business successes. This was the case of the two generals responsible for the massacre of the four American nuns in 1980, Carlos Vides Casanova and José Guillermo García. In Miami they put on a suit and tie and started businesses with the help of "the community." No one who saw them in meetings or walking the streets of Miami (except a doctor and a professor who recognized them decades later) suspected that these respectable gentlemen were, in fact, genocidal.

Of In the same way, very few could guess that terrorists like the Cubans Luis Posada Carriles, Orlando Bosh and many others (in *La frontera salvaje* detailo several cases) classified as "terrorists" by the FBI itself, took sun on the beaches of Miami and met with "businessmen" most successful in the country. All "freedom fighters" planning bomb attacks (such as the assassination of Orlando Letelier and his secretary with a car bomb steps from the White House, or with the bomb on Cubana flight 455 that killed 73 people) or simply stop harassing or eliminating uncomfortable people with more conventional methods.

The Miami-based list of mafia and terrorist organizations is too long to include in an article, but it will suffice to say that, with exceptions, it is consistent with its degree of impunity, some for having belonged to the CIA and others for their connections policies. The Center for Justice and Accountability, based in California, registers more than a thousand foreign criminals, VIP class, living in the United States. Now, you don't have to be a genius to guess which candidates these "successful businessmen" support, responsible for various genocides.

In the most recent election campaign in the United States, the traditional press, television and social networks bombard us with a political propaganda that is a copy of all the previous ones. One of them is that of the powerful senator for Florida, Marco Rubio (in Congress for 22 years), with the simplicity of the McDonald's menu that the extreme right likes so much. In all of them, the senator appears with images of poor immigrants crossing the border as if they were going to invade the still first world power. In other speeches these men are accused of having a disproportionate sexual appetite, that is, the same

accusation of the pornographic imagination that nineteenth-century slaveholders had about a possible liberation of slaves and the rape of blonde girls.

In one of those ads, Senator Rubio repeats a cliché that I have already answered before (*The UNESCO Courier*, [2019](#)): "They accuse us of racism for defending our laws (and) for defending our borders" (October 2022). An old masterpiece of hypocrisy that, for Resolve the contradiction between two terms, one is eliminated. Eliminate History (in Florida) Governor DeSantis succeeded in banning review it) and simplify to a strategic degree, which is the best How to win elections.

Is Just as we arrived at the criminal hypocrisy of the powerful establishment "Latino", especially in Florida, for which women are criminalized victims of the barbarism designed in their countries (which, moreover, do not vote), while the genocidaires of those same countries enjoy legality and of the old mafia network and, naturally, they contribute money to the political campaigns of those who will benefit and protect them.

All in the name of freedom, the fight against communism, against heretics and alien invasion.
