Washington seeks in the UN to justify a millionaire robbery

For several years Washington has stolen, under any justification, the capital that several governments of the world, which are not related to its policy, have deposited in US banks.

This policy of plunder has led many nations to understand that wealth cannot be kept in these financial institutions because some have specialized in appropriating their treasures under any excuse.

The past 14 of November after adoption (94 votes in favour, 14 against and 73 abstentions) of the draft resolution, Moscow's ambassador to the UN, Vasily Nebenzia, said that the West tries to give the appearance of legitimacy, through General Assembly, in its attempt to steal Russian assets frozen and used to pay for the weapons it supplies to Kiev and the damage caused to Ukraine by that conflict.

As with many of these UN resolutions, they are not binding and therefore not complied with, although they can provide Washington with a cute to look good before world public opinion if in the end it manages to keep that bulky sum of Russian money.

Russian Security Council Deputy President Dmitry Medvedev declared the resolution completely illegal and warned that if the West, based on such arbitrariness, commits such theft, "Russia will have no choice but to irrevocably withdraw money and assets from private investors from those countries."

Medvedev said that with these bad arbitrations the General Assembly of the UN is losing its position as the world's leading institution for peace, and demanded: "That it issue the same recommendation on the **fullcompensation** by Washington to Korea, Vietnam, Iraq, Yugoslavia and **others numerous victims of the United States and NATO.**"

Otherwise, the Russian official continued, the situation it seems to be the beginning of a UN agony.

"The end will be painful for the entire international community. We will live without such an organization of the "united nations..."

For his part, the Minister of Foreign Affairs, Sergey Lavrov said that if this robbery materializes, "it would be the destruction of the basis of international relations, they would hit the Europeans themselves, to the financial system and undermine confidence in Europe and the West in general, because it is a total arbitrariness similar to the law of the jungle."

And he emphasized, "we could ask, how long how long Will these embezzlements be allowed to continue to occur? There is no room for the slightest He doubts that a new economic, financial, legal order is needed, and about everything, morality that stops these arbitrariness."

Recall that in recent decades, the United States and allies of NATO have Bombed and destroyed numerous countries under the pretext of the threat Communist, the defence of human rights, the fight against terrorism or by any fallacious excuse and they have not compensated those nations.

It would only be enough to recall a few: Vietnam, Nicaragua, Yugoslavia, Iraq, Libya, Syria, Afghanistan, and despite the trillions of dollars and millions of human lives that they caused to those peoples, the UN has not even condemned them.

As for the theft of capital deposited by different countries in banks in the United States and Europe, these acts of robbery and robbery have been It happened for several decades.

Let's comment on a few: In 1979, when the triumph of the revolution in the Islamic Republic of Iran, the assets of the Persian nation were cut off by Washington, banned Iranian oil imports and froze some \$30**billion** dollars in assets.

No remnant to the law A New York court ordered those Iranian assets to be used to compensate the victims of 11 September 2001, despite that the Republic Islamic was not involved in the terrorist attacks.

After of the invasion and occupation of Iraq, the United States in 2004 allocated 15,000 Tehran's million dollars to the supposed reconstruction of that nation Arabic, while billions of dollars from the country's reserves.

The same happened with the 7 billion Central Bank of Afghanistan dollars placed in financial institutions American. The White House, In February 2022, he ordered those funds to be used to "help" the victims. of September 11.

In Libya, after the NATO invasion, 13 billion dollars were frozen in a Belgian bank, another 2 billion in financial institutions in Italy, 12.5 billion in British headquarters and 30 million billion in the United States, and they all disappeared.

To Venezuela has frozen him in England, 30 billion in gold, Washington has snatched from Caracas, billions of dollars in money and property like the Citco gas stations, while Cuba has been blocked since 1963 About \$1 billion has been given to members of the Cuban-American mafia based in Miami through trials Fraudulent.

In a world that is increasingly moving towards multilateralism, the Western countries led by the United States cannot continue to strip the nations of the South and the emerging ones of their legitimate wealth, much less use the UN General Assembly to commit their misdeeds.
