## Close Guantanamo Protest Decision

Nearly 14 Years back when the American troops attacked Afghanistan, against all the human rights conventions and without any court decision human are kept in Guantanamo Bay, it has been 14 years now that human appears in orange cloths with fasten hand and covered faces in this bay. As soon the American got involved in war in Afghanistan, beside Bagram Base and Kandahar the Americans took some war detainees to Guantanamo bay, all the rights that has been given by the international law are taken from these Detainees in Guantanamo Bay.

In 2008 election President Obama has promised to Americans and people around the world that he will close Guantanamo but still 100 humans are kept in Guantanamo bay, today we protested and

condemn the American Government for this, we call on the human conscience of the world to join us in our call to the government of America, if they cannot prove crime on this Detainees than United State should release these Detainees as soon as possible and send them to their own countries.

**We the protesters want the Followings:**

1. The Government of America should act with Guantanamo prisoner according to the Human Rights International Conventions, and the American Human Rights law and regulations, these Detainees should be given their rights and should be given access to judiciary and court trial.
2. The Government of America should compensate for the indignity of these Detainees and compensate for keeping them in prison. We understand that no amount can treat the wounds of the prisoner and their family members, but the American politicians should realize that peace always asks for justice.
3. We also ask the government of America to close the prisons in Bagram, Europe, and East Asia and also all those known and unknown prisons are the world, and should behave with the Detainees according to Human Rights Conventions.
4. The National Unity Government should specifically clarify that against and previous decision of government responsibility of Bagram prison has been given back to Americans.
5. We along and together with the other Freedom Asking Movements, would like to record and archive all those violence against the Detainees by America as International War Crime and submit it to International Court of war.
6. Finally we request from the government of America and especially from President Obama to fulfill his promise to the people of America and rest of the world to close Guantanamo and keep his promise.
